

## Fur Takers of America Carol Krumwiede Trapper Education Grant

1. Goal: Program is designed to support, promote and help chapters and affiliates produce, conduct or otherwise promote the trapping industry with the help of the Fur Takers of America family. To this extent eligible activities would include but are not limited to Trapper's Education and General Promotion of the Trapping Industry.
2. Purpose:
  - a. The purpose of this program is to aid organizations within the FTA family in fostering educational programs, support and encouragement of local training events, and the development of new programs and events.
  - b. The grant program is primarily designed to help with new program and improvements to existing programs. The maintenance and routine operating expenses of ongoing program would not be a proper use of this grant program.
  - c. Organized programs, providing support for presentations at professional conferences, support to education individuals whom would be expected to further the cause and purposes of FTA mission and goals.
  - d. Any and all projects, activities, and programs that would be expected to further the mission and purposes of the FTA in supporting, promoting or otherwise improve the trapping industry for the benefits of any and all trappers.
3. Funding: The program has been funded initially by the Governing Board and may be funded annually as needed or desired by the Governing Board. Contributions and donations specific to this program may also be accepted and would remain allocated to this purpose.
4. Applications will be accepted throughout the year. An application will be evaluated and made available to all chapters and affiliates. Applicants may request funding, materials, or any combination of both. Applications shall be evaluated periodically as needed not more than 60 days from submission and response to application not more than 90 days from submission. Committee may reject, disapprove, request more information and re-evaluate and may approve partially or fully.
5. Evaluation of request:
  - a. Active Chapter or Affiliate of Fur Takers of America will submit all applications. Does not need to be for a program put on by the Chapter or Affiliate; however, the request must be made and officially be sponsored by a Chapter or Affiliate. (i.e. the Nebraska chapter would like to sponsor an educator to attend a conference to promote trapping to other educators. NE Chapter submits application to FTA Carol Krumwiede Trapper Education Grant Committee, and the grant is evaluated.)
  - b. Priority and preference may be given to:
    - (1) Improvement of an existing education program,
    - (2) Educational opportunities that are targeted to both youth

- and adult first-time trappers and those that offer a hands-on environment.
- c. Programs, events, and opportunities should recognize The Fur Takers of America in printed handouts, flyers, or education materials.
6. Conditions of grants:
    - a. Funds, materials, and support must contribute to a positive image for, and promotion of, the fur industry, Fur Takers of America, and trapping in general.
    - b. Recipients of Funds, materials, and support must give recognition to Fur Takers of America in printed, multi media, and other materials, if available.
    - c. Recipients of Funds, materials, and support must provide follow-up report on successes and/or failures of programs funded by the grant.
    - d. Recipients of Funds, materials, and support will write a magazine friendly article about the program and submit that written summary for possible inclusion in the "Fur Taker magazine" must also agree to allow the FTA to promote, discuss and write about the program, events or functions funded by the grant.
